






















With a population of 47/484, Chesterfield is the most populous city in West St. Louis County and the 14th most populous in the state of Missouri, is the 2nd largest city in St. Louis County, comprising 32 square miles. Incorporated in 1988, Chesterfield is a thriving residential and business community with two top-rated school districts, a top 50 rated hospital, unlimited shopping and dining destinations along with historic and cultural attractions.

Chesterfield is home to more than 2,000 businesses with over 36,000 employees working in the community. Reinsurance Group of America, Dierbergs, Kellwood and Broadstripe are all headquartered here. The top employers in Chesterfield include St. Luke's Hospital, Delmar Gardens Enterprises, Monsanto, Reinsurance Group of America and Dierbergs. Around the St. Louis region, Chesterfield is known as a shopping and dining destination with over 150 restaurants and hundreds of retail shops. Chesterfield Commons, in the Chesterfield Valley, is comprised of over two million square feet and, at 1.5 miles long, is the largest outdoor shopping center in America. Opened in 1976, Chesterfield Mall is located at the intersection of 1-64/40 and Clarkson Road. In the summer of 2013, two outlet malls opened in the Chesterfield Valley. St. Louis Premium Outlets includes 90 upscale outlet stores, and Taubman Prestige Outlets is comprised of 310,000 square feet of village-style, outdoor shopping space.

Chesterfield has a wide variety of outdoor and indoor recreation options. Faust Park was created in 1968 and encompasses nearly 200 acres. Chesterfield's Central Park includes the Chesterfield Amphitheater and Chesterfield Family Aquatic Center. The Chesterfield Valley Athletic Complex, located along 1-64/40, is a 176-acre complex with baseball/softball game and practice fields, football game and practice fields, soccer fields and multi-use fields. The Hardee's leeplex, the largest skating facility in Missouri, features two professional sized arenas and one Olympic sized arena.








